

PRIVACY POLICY

The NZ Ultramarathon Festival – refers to the 10 day, 6 day, 72hour, 48hour, 24hour, 12hour, 6hour, 3hour events for Individuals, and the 24hour, 12hour, 6hour and 3hour team events.

The NZ Ultramarathon Festival is committed to protecting the privacy of your personal information.

The NZ Ultramarathon Festival will only use your personal information when it is necessary for us to deliver you a service or perform other necessary business functions and activities.

The NZ Ultramarathon Festival will not use or disclose your personal information for purposes unrelated to the services we provide, unless we first obtain your consent.

The NZ Ultramarathon Festival will only collect personal information about you by lawful and fair means, and not in an unreasonably intrusive manner. It is The NZ Ultramarathon Festival's usual practice to collect personal information, about you (and possibly your family) directly from you, or from your authorised representative, when you:

- register for an event organised by The NZ Ultramarathon Festival
- complete a hard copy form'
- purchase goods or services from us;
- enter one of our competitions; or
- contacted us by telephone, via mail, email or online.

The types of personal information The NZ Ultramarathon Festival may collect includes (but is not limited to) your:

- name;
- date of birth;
- gender;
- residential address;
- email address;
- contact telephone numbers;
- medical conditions;
- emergency contact details

The nature of the information collected will depend on the purpose for which it is being collected.

If you provide us with information about any third party, you must obtain that person's permission to give us the information and inform them that you have given the information to us.

We use your personal information for a variety of reasons including to:

- provide services and products to you;
- answer your inquiries and deliver customer service to you;
- meet our legal obligations.

Whilst you may opt not to provide us with your personal information, you should be aware that without this personal information, we may not be able to provide you with some/ all of the services and/or products you are seeking.

In the course of conducting our business and providing our products and services to you, we may disclose your personal information.

If you are a registered athlete in an event your name, gender, age group, town, & country may be displayed on the publicly available start list and results.

We only disclose personal information for the purposes for which it was given to us, or for purposes which are directly related to one of our functions or activities. We do not give it to anyone else unless one of the following applies:

- you have consented to the disclosure;
- you would reasonably expect, or have been told, that your information is passed to those individuals, bodies or agencies; or
- it is otherwise required or authorised by law.

If we engage third party agents or contractors, we will take all reasonable steps to ensure that they do not breach privacy requirements in relation to the information, before we share your personal information with them.

We may disclose your personal information to:

- professional providers (such as the event medical provider);
- professional advisers (such as lawyers or auditors);
- payment systems operators and financial institutions;
- third party agents or contractors with whom we contract in the ordinary course of business;
- organisations authorised by The NZ Ultramarathon Festival to conduct promotional, research or marketing activities;
- upon lawful request from law enforcement agencies or government authorities; and
- any persons acting on your behalf including those persons nominated by you, executors, trustees and legal representatives.

In all circumstances where your personal information is disclosed, we will take all steps reasonable to ensure that these third parties undertake to protect your privacy.

Direct marketing

We are committed to compliance with all laws and requirements relating to the use of your personal information. We will only use or disclose your personal information for direct marketing purposes if you have provided your information for that purpose (and you would expect us to use the information for that purpose), or if you have provided consent for your information to be used in this way.

From time to time, we may contact you with information about products and services offered by us and our related entities and our business partners and sponsors, which we think may be of interest to you. When we contact you it may be by mail, telephone, email or SMS.

Where we use or disclose your personal information for the purpose of direct marketing, we will:

- allow you to request not to receive direct marketing communications (also known as ‘opting-out’); and
- comply with your request to ‘opt-out’ of receiving further communications within a reasonable timeframe.
